### **Background:**

IFEducation is a 501c3 Non-profit organization founded in 2013 to make Higher education affordable by offering 0% interest student loans. All funding for these loans comes from tax deductible donations from donors and sponsors. Students repay the loans after graduation and the returned funds are used again for new student applicants.

### **Proposal:**

This is the proposal for a corporate sponsorship where companies can make a tax deductible donation to IFEducation and select the student applicants to be awarded our 0% Interest student loans.

The selected students can belong to a local university in the community, can be the children of the companies' employees, or can belong to a group that the company has an interest in sponsoring. Selected students must submit an application and be eligible to receive the loan award.

In the case of a corporate sponsorship of students belonging to a university, IFEducation can work with the company to recruit eligible student applicants. Eligible student applicants will then be awarded the sponsored loan after signing a repayment contract. The 0% interest student loan eligibility and amount is determined by FAFSA, which determines the loan amount that the student qualifies for on a need basis. The goal of IFEducation is to award these 0% interest loans to replace the traditional interest bearing loan that a student would get through FAFSA.

In the case of a corporate sponsorship of students already identified by the corporation, these students will also have to submit an application to IFEducation. After receiving the applications, repayment contracts, and the sponsorship donations, IFEducation will administer the 0% interest loans. For sponsored students individually identified by their sponsor, they will receive the entire sponsored loan award even if FAFSA determines lower loan eligibility.

### **Benefits of a Corporate Sponsorship:**

By becoming a corporate sponsor, you are helping the community by making higher education more affordable and accessible. By helping students get a degree, you are helping to grow your future talent and strengthen your communities.

Through IFEducation you can participate in charitable giving by making a tax-deductible donation to sponsor students. These students can be chosen by you, the sponsor, and can be from the local university or from your corporate family as the students of your employees.

### **Next Steps:**

Simply choose the package you want to participate in or an alternative sponsorship donation that fits your needs. Our packages are:

Gold for \$80,000  
Silver for \$50,000  
Bronze for \$25,000

Each package can sponsor a number of awards of either \$5,000 or \$10,000.
